Overview of U.S. MSA Exports

In 2021, exports from the United States' **392** Metropolitan Statistical Areas (**MSAs**) *totaled \$1.75 trillion*, reflecting a **22.5** *percent increase* over 2020.

- Of the 392 MSAs, 158 metropolitan areas exported more than \$1.0 billion in merchandise to the world, including seven Florida MSAs.
- A total of 17 metropolitan areas exported
 merchandise worth more than \$25 billion worldwide,
 including one Florida MSA. This is an increase from the
 12 MSAs exporting this amount in 2020.




• Non-metropolitan areas accounted for another \$199.5 billion of all U.S. exports in 2021, comprising 11.4 percent of total U.S. exports.

Florida MSA Export Highlights

- Florida MSA exports sustained growth from 2017 to 2019, increasing by 3.7 percent. Across the U.S. and in Florida, exports in 2020 fell due to the COVID-19 supply chain crisis. Metropolitan exports decreased by 16.8 percent through 2020. Florida's MSA exports rebounded in 2021, boasting 21.7 percent annual growth and surpassing 2019 levels.
- In 2021, Florida's 22 MSAs accounted for \$55.5 billion in exports, comprising 3.2 percent of all U.S. MSA exports, while another \$764.2 million in exports originated in Florida's non-metropolitan areas, a 28.9 percent increase over 2020.
- Throughout 2021, all of Florida's 22 MSAs saw export growth; no MSAs in Florida experienced decline.



 Seven of Florida's MSAs each generated more than \$1.0 billion in exports in 2021, comprising a 93.3 percent share of Florida's total MSA exports.

Miami MSA Export Highlights

- The <u>Miami-Fort Lauderdale-West Palm Beach MSA</u> accounted for nearly 65 percent of all Florida exports. It was also the only Florida MSA to rank as a top 50 MSA exporter in the entire U.S. (7th), with merchandise shipments totaling \$36.0 billion.
- At the county level, two-thirds of Miami MSA exports were shipped through Miami-Dade County.



Southeast Florida continues to export globally, with North American, Latin American, and European
partners acting as primary markets for the Miami metropolitan area. Nearly 30 percent of exports
from the Miami metropolitan area are destined for its top 5 markets.

- ➤ The Miami MSA exported \$16.4 billion in goods to Free Trade Agreement (FTA) countries in 2021. Nearly 46 percent of the exports from this MSA went to FTA Partner countries.
- Top commodity exports by NAICS description from the Miami MSA include:
 - Aerospace Products and Parts (\$5.6 billion);
 - Communications Equipment (\$3.7 billion);
 - Computer and Peripheral Equipment (\$2.8 billion); and
 - Pharmaceuticals and Medicines (\$1.6 billion)
- More than 27,000 companies exported from the Miami-Fort Lauderdale-West Palm Beach MSA in 2020. (Latest data available).







- The highest percentage growth was seen in The Villages MSA, growing by 156.9 percent in 2021, more than doubling its exports from \$21.1 million to \$54.2 million.
- The Miami-Fort Lauderdale-West Palm Beach MSA saw the largest dollar value growth, adding nearly \$6.9 billion in exports in 2021.
- The Tampa-St. Petersburg-Clearwater and Orlando-Kissimmee-Sanford MSAs saw the next highest dollar value growth, seeing export increases of \$672.5 million and \$463.8 million, respectively.

Florida MSA Exports by Region

- Florida's eight regions are represented in the standard metropolitan statistical areas. Of those eight regions, Southeast Florida had by far the highest value of exports in 2021 with a combined total of \$36.5 billion, an increase of 23.5 percent from 2020. The Tampa Bay and East Central regions ranked second and third with exports of \$7.7 billion and \$5.4 billion, respectively. Both Tampa Bay and East Central regions saw increases of 14.4 and 21.5 percent, respectively.
- All eight Florida regions saw *increases in exports* from 2020 to 2021: The *Southeast* region had the largest increase of \$6.9 billion, while the *Tampa Bay* and *East Central* regions experienced the second and third largest increases of \$968 million and \$949 million, respectively, through 2021.

Florida MSA Exports by Sector

The top sectors for products exported from Florida's MSAs on a 3-digit NAICS basis include: Computer and Electronic Product Manufacturing; Transportation Equipment Manufacturing; Chemical Manufacturing; Machinery Manufacturing and Processed Foods Manufacturing.

- In 2021, \$35.7 billion worth of goods in these sectors were exported from Florida across the world. This is an increase from 2020 of over \$7 billion in these key sectors.
- 65.7 percent of goods exported from Florida's MSAs were in one of these categories in 2021, an increase from a 64.3 percent share in 2020.

The total export value was \$569 million, representing 1.0 percent of total exports from Florida.
- ➤ 6) Fabricated Metal Product
 Manufacturing accounted for a 0.9 percent share of goods exported from Florida's MSAs in 2021, valued at \$458 million dollars.

Notes on Disclosure of Export Data

The 392 U.S metro areas for which it is possible to release some export data, disclosure regulations still limit or prevent the release of much detail on foreign markets and the industry composition of exports. Manufactured product detail, even for the largest exporting metropolitan CBSAs, is limited to broad, four-digit NAICS (North American Industry Classification System) categories. Information on market destinations, while generally more complete than data on product composition, is also subject to important disclosure-induced limitations. For additional product detail, it is recommended to contact the U.S. Census Bureau's International Trade Macro Analysis Branch as the data may be available for purchase.

Methodology

All state and metro area export values are derived from the U.S. Census Bureau's Origin of Movement-ZIP Code Based Series (OM-ZIP). This series, which the Census Bureau reintroduced in 2006, allocates exports to states and localities based on the address of the United States Principal Party in Interest (USPPI) of record.

The USPPI of record is not necessarily the entity that produced the merchandise; hence, the series does not furnish complete and reliable data on the production origin of U.S. exports.
